Overview

The TAMIM Global Mobility portfolio is a global long/short strategy that seeks to invest in companies which benefit from the ongoing \$7-10 trillion autonomous and electric vehicle revolution while shorting those that will suffer.

Commentary

The unit class generated a -6.80% return in January, resulting in a net return to investors of -15.47% since inception in February 2022. For reference, over the same period the S&P/Kensho Transportation index has returned -30.64%.

Overall, the portfolio was net long 20.80% with positions in uranium and DoorDash (DASH.NYSE) contributing to returns while long positions in Alibaba (BABA.NYSE) and Cerence (CRNC.NASDAQ) detracted.

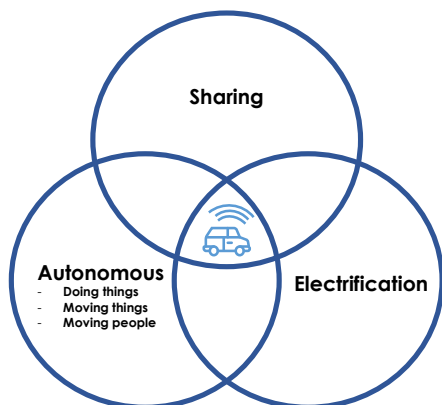

\$7-10 Trillion Revolution: That's right, trillion with a "T." We believe this is going to be the biggest technological revolution of our lifetime... and very few are paying attention.

Every Industry Will Be Affected: We believe there will be massive winners and significant losers – given our structure, we plan to make money on both. On the loser side, think about the industries that will disappear: car rental companies, internal combustion engine (ICE) components, and Big Oil...



Multiple Ways to Win: While the end state is already coming into view, there are multiple building block evolutions that we are actively seeking to capitalize on – namely, Sharing/Connectivity, Electrification, and Autonomy.
