

TAMIM Fund: Credit generated a 0.66% return in July, resulting in a twelve-month net return to investors of 6.30%. The June quarter distribution was 1.7%. Since inception, the portfolio has delivered an annualised return of 7.24% p.a. net of all fees. Over the six years and 10 months since inception, the Fund has only had one negative month and has paid a quarterly distribution of between 1 and 2.24% every quarter. The next quarterly distribution is scheduled to be paid on 20 November 2025. TAMIM remains committed to investing with larger, more established managers and avoiding those that are unproven, especially in the current environment. We also continue to focus on senior secured exposure through deals secured by real assets or business cash flows.
